**IF THE PRETRIAL INFORMATION FORM HAS BEEN SUBMITTED BY DECEMBER 17, 2025, YOUR PRESENCE AT THE CALENDAR CALL IS NOT REQUIRED.**

If there has been a demand for a jury trial, a Consolidated Pre-Trial Order must be emailed to the Court by February 16, 2026. The trial calendar will be filed at least 20 days prior to the beginning of trials. Effective as of the date the Consolidated Pre-Trial is due, no amendments or further discovery shall be allowed except by order of the Court.
