If there has been a demand for a jury trial, a Consolidated Pre-Trial Order must be emailed to the Court by July 31, 2026. The trial calendar will be filed at least 20 days prior to the beginning of trials. Effective as of the date the Consolidated Pre-Trial is due, no amendments or further discovery shall be allowed except by order of the Court.
